Overview: CAMP 360 is a program designed to reach the entire child, full circle all 360 degrees. Campers will be able to experience and participate in fun and engaging activities while also learning how to work together and interact with one another. Led by teachers and camp counselors, activities will include team building, relay races, slime making, book club, theatrics, arts and crafts, music and dance, presentations, and guest speakers.

Who: This year we are taking up to 150 campers for the summer! The camp are for those students who are attending summer school in the morning, as well as any additional students of the parish who would like to attend. Campers will be taken on a first come first serve basis in terms of registration. We will not accept any registration packets after we reach 150 campers. Campers must be an Iberville Parish Resident entering grades 3rd, 4th, 5th, and 6th.

Transportation: Students attending summer school at an IPSB school will be the only campers to have bus transportation to and from their home camp (siblings who are not enrolled in summer school cannot ride the bus). All other campers must be carpool drop off and carpool pick up. If you are interested in having your student attend CAMP 360, please complete the registration packet.

Registration packets are **due no later than Friday, May 22, 2026**. Please turn in your registration packet before May 22nd to either the IPRD Office or your elementary school's front office.

CAMP 360 Policies

Behavior Management/Zero Tolerance:

Our CAMP 360 staff will create a fun and safe environment for all participants in the program. Praise and positive reinforcement are used as effective methods of behavior management. Children who do not respond to these methods or who are destructive to others or to property will be dealt with in a professional, positive, and timely manner to correct the behavior. The following procedures will be followed for behavior management.

1. In the event a child's behavior is a repeated behavior and cannot be corrected by the CAMP 360 staff with a verbal warning or other form of behavior modification, a parent or guardian will be contacted and that child will not be allowed to return to camp.
2. If a child instigates or participates in fights, a parent or guardian will be contacted and that child will not be allowed to return to camp.
3. If a child misses three days or more, they will not be allowed to return to camp.

NOTE: Immediate dismissal from the program can occur at any time given severe circumstances

Liability Statement:

I, (Guardian Name) _____, hereby acknowledge my awareness that my child's participation in Iberville Parish CAMP 360 may involve activities which include, but are not limited to, the following: stretching, running, jumping, kicking, throwing, swinging, catching, sliding, and bodily contact with other campers and with athletic equipment. It may also involve competitive sports which use various types of athletic equipment which include, but are not limited to, the following: balls, bats, rackets, helmets, cleats, pads, nets, frisbees, goal posts, sticks, pucks and/or other athletic equipment. I also understand that my child's participation in the aforementioned activities may expose my child to risks of property damage and bodily or personal injury, including injury that may be fatal, and any one or more of the following: injury from slipping, tripping and falls; sickness; foreseen and unforeseen inclement weather; cuts; abrasions and puncture wounds, broken bones; injury from uneven terrain on the fields; injury from contact with other campers and from contact with athletic equipment; muscle strains and sprains; concussions; drowning; and heart attack. In addition, I understand that my child may be exposed to other risks which may not be foreseeable. I knowingly and freely assume, on behalf of my child, any and all such risks and voluntarily participate in this activity. I understand that it is my responsibility, as the participant's parent, to allow my child to engage only in those activities which are appropriate.

I acknowledge that my child must follow the instructions of the activity leader at all times. In addition, I understand that none of the following entities provides insurance coverage for my child's participation in Iberville Parish CAMP 360. In exchange for the use of equipment, materials, supplies and for being allowed to participate in this program, I hereby release and forever discharge Iberville Parish CAMP 360, and all sponsoring agencies and their members individually and their officers, agents, and employees from any and all claims, demands, rights, expenses, actions, and causes of action, of whatever kind, arising from or by reason of any personal injury, bodily injury, property damage, or the consequences thereof, whether foreseeable or not, resulting from or in any way connected with my child's participation in this activity.
